**Public Meeting Minutes
January 21, 2021**

Call to Order:

Commissioner D. L. Humphrey called the meeting to order at 6:30 pm with a moment of silence. Commissioner T. Brown called the roll and the following Commissioners were in attendance: Chioma J. Iwuoha (7B01), Tiffany L. Brown, (7B02), Cydne Smith Nash (7B04), Donna Robinson (7B05), Kelvin Brown (7B06), and D. Lynnell Humphrey (7B07). A quorum was achieved with 6 of the 7 Commissioners present.

Approval of Agenda:

The agenda was reviewed. Commissioner T. Brown moved that the agenda approved with the following addition – approval of ANC 7B Calendar for 2021. The motion was seconded by Commissioner K Brown. Motion carried.

Election and Installation of Officers:

Review of Community Meeting Minutes

Treasurer's Report

The treasurer's report was tabled. Office Manager Sheila Brown stated that the Commission had not yet received the bank statements for November 2020 and December 2020.
